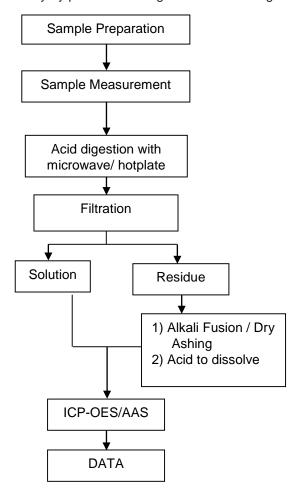

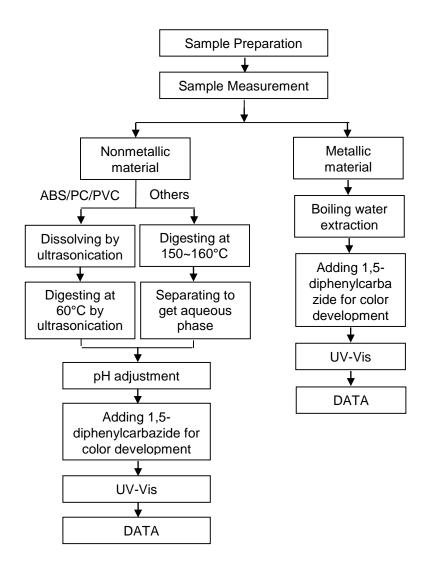



#### **Phthalates Testing Flow Chart**







#### **Chlorinated Paraffin Testing Flow Chart**







#### **Elements Testing Flow Chart**







#### **Halogen Testing Flow Chart**







#### **HBCDD Testing Flow Chart**









#### **PCN Testing Flow Chart**







#### **PCT Testing Flow Chart**







#### **PVC Testing Flow Chart**







## **Red Phosphorus Testing Flow Chart**







## **TBBP-A Testing Flow Chart**







#### **Organotin Testing Flow Chart**







#### PFASs/ PFOS/PFOA Testing Flow Chart







#### **PAHs Testing Flow Chart**






