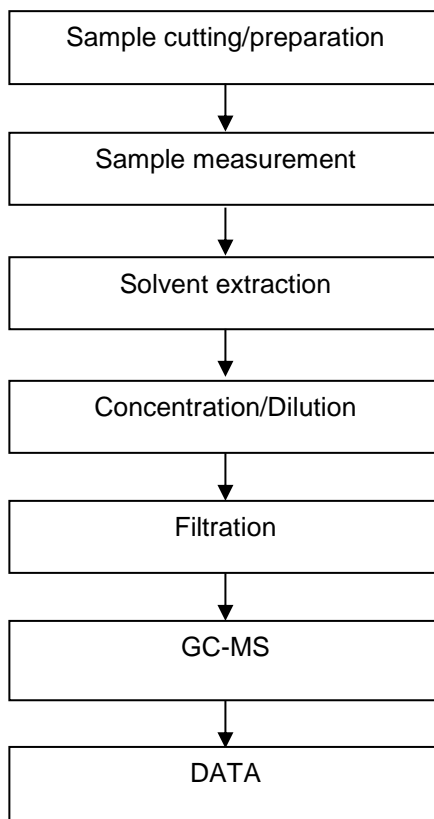

Phthalates Testing Flow Chart



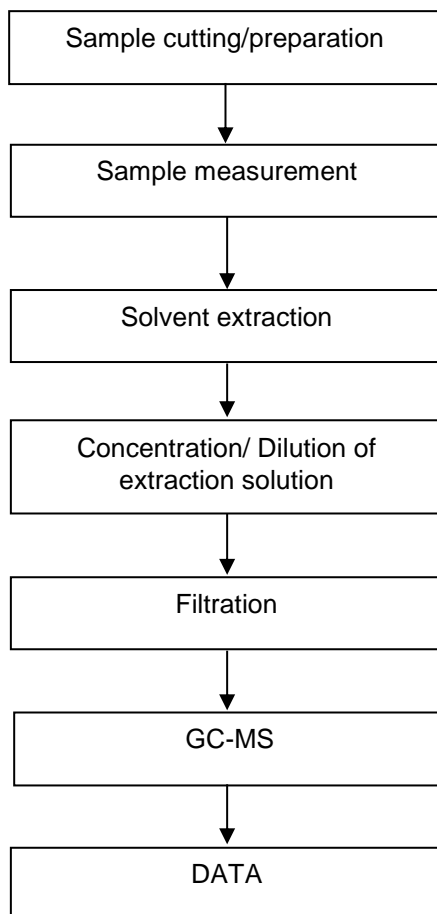

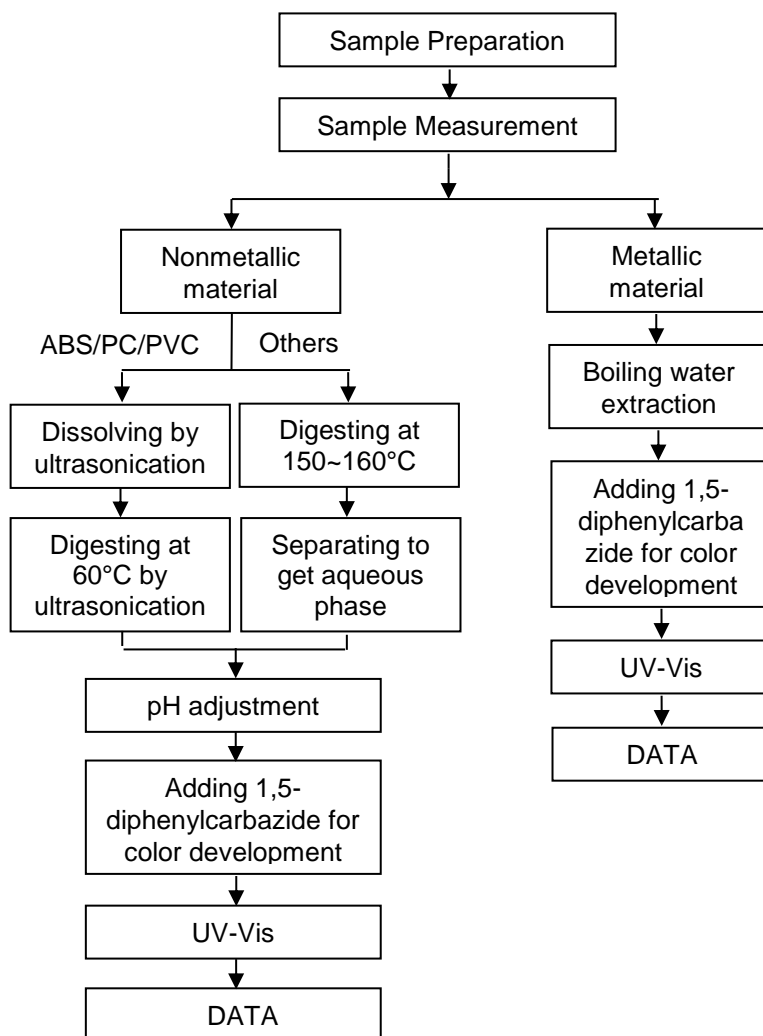

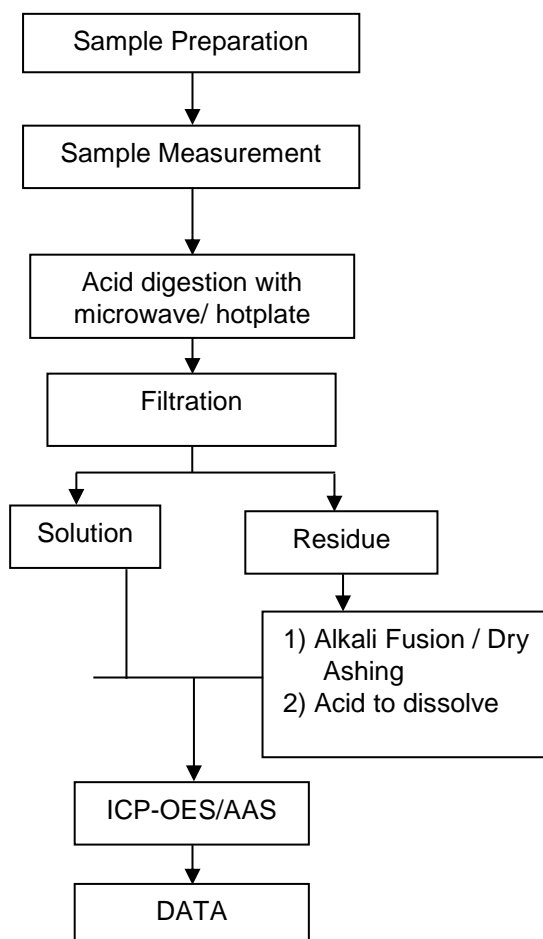

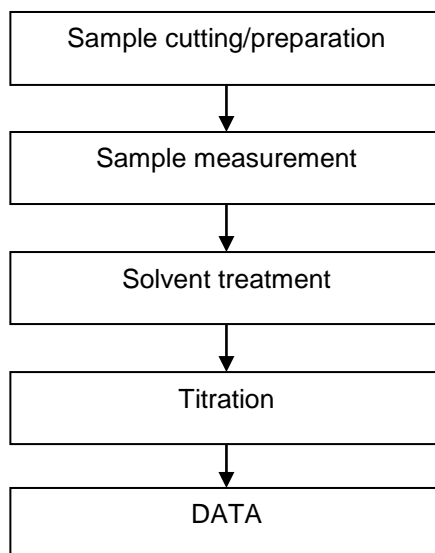
