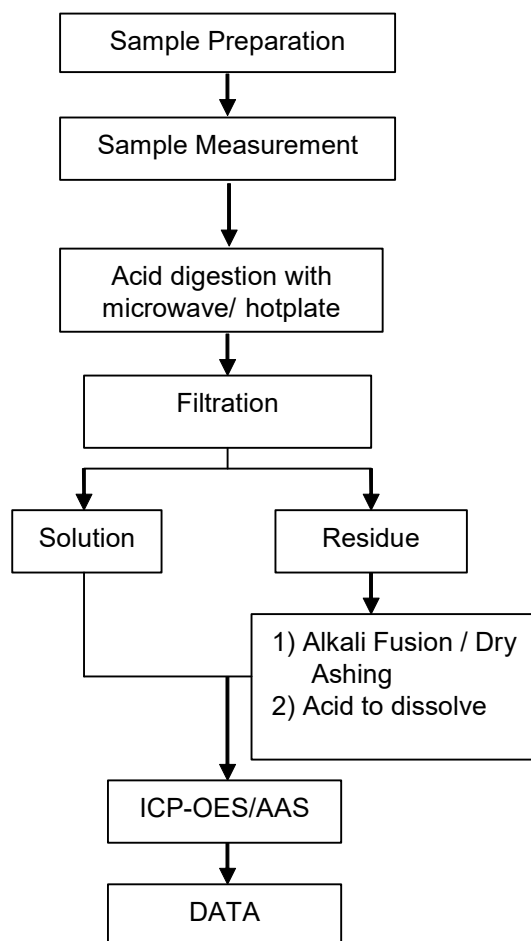

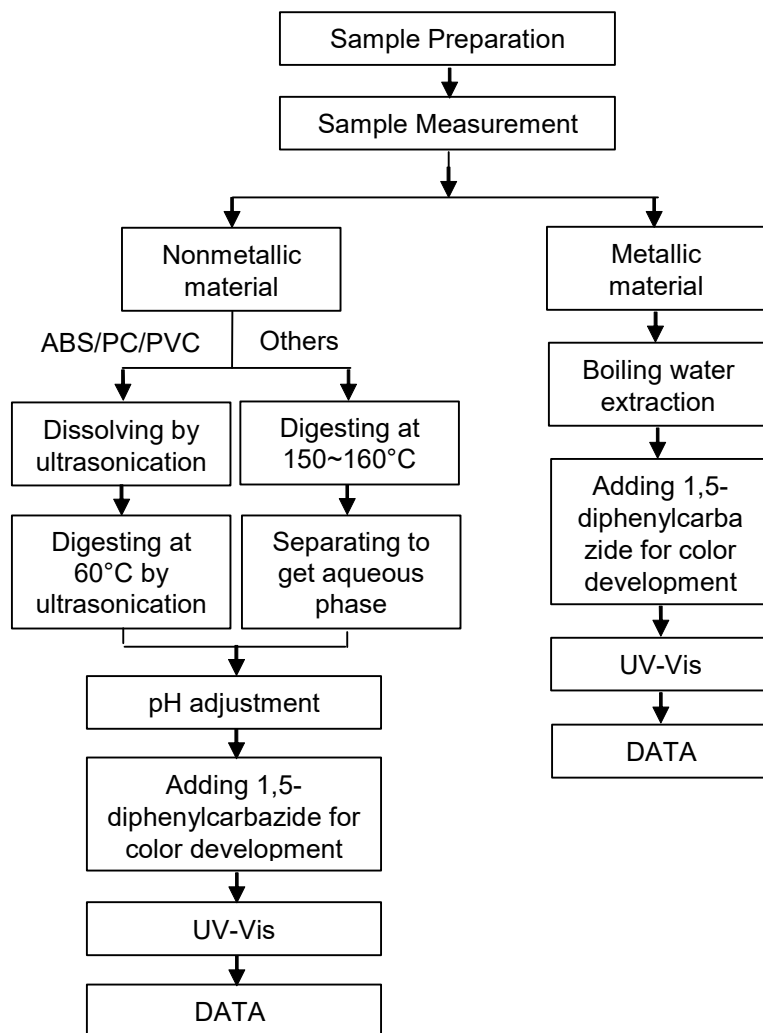

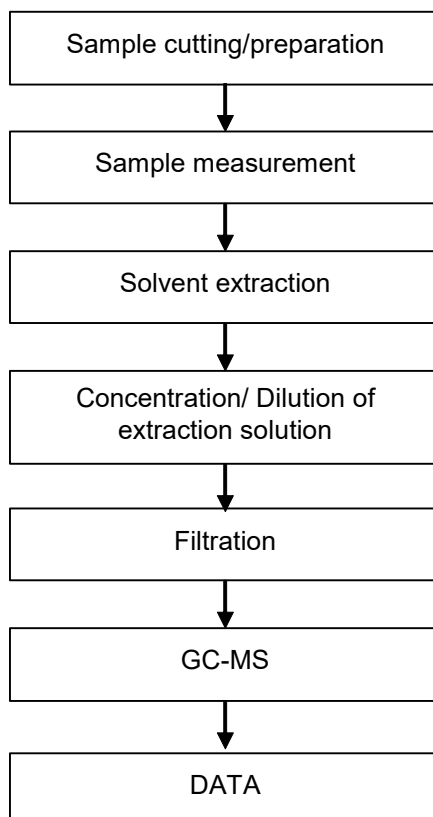

### PBBs/PBDEs Testing Flow Chart

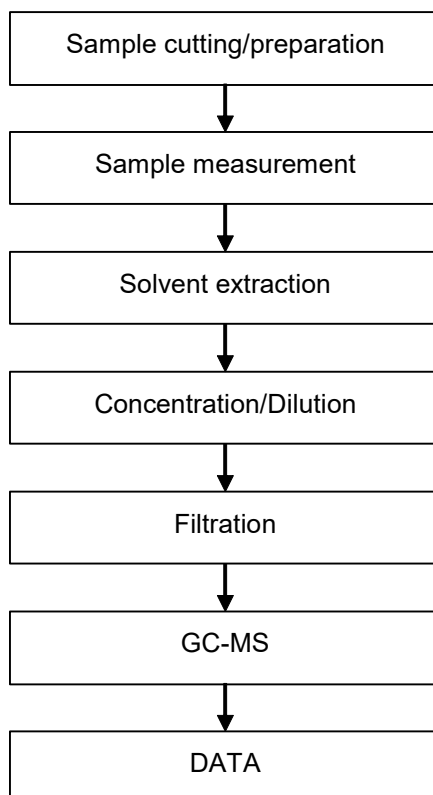

### Phthalates Testing Flow Chart



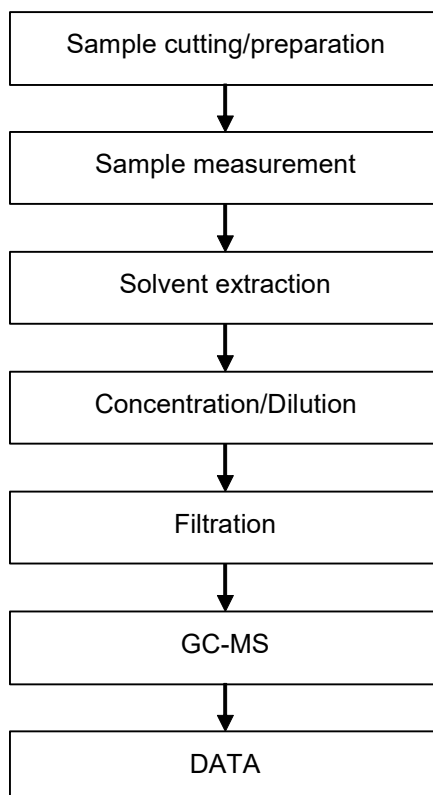

### HBCDD Testing Flow Chart

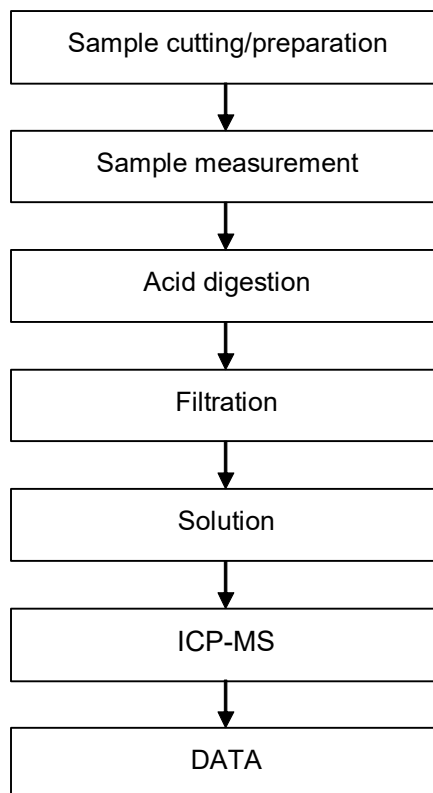
