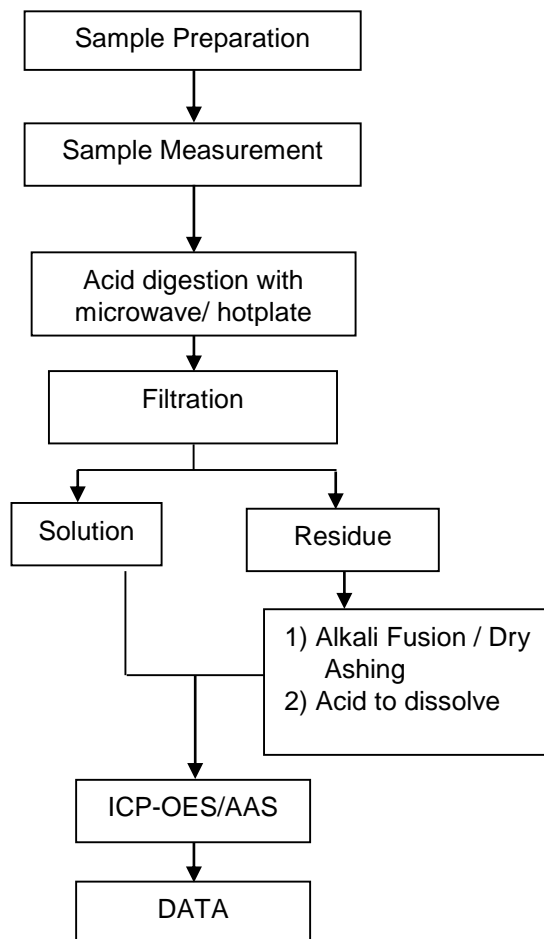

These samples were dissolved totally by pre-conditioning method according to below flow chart.

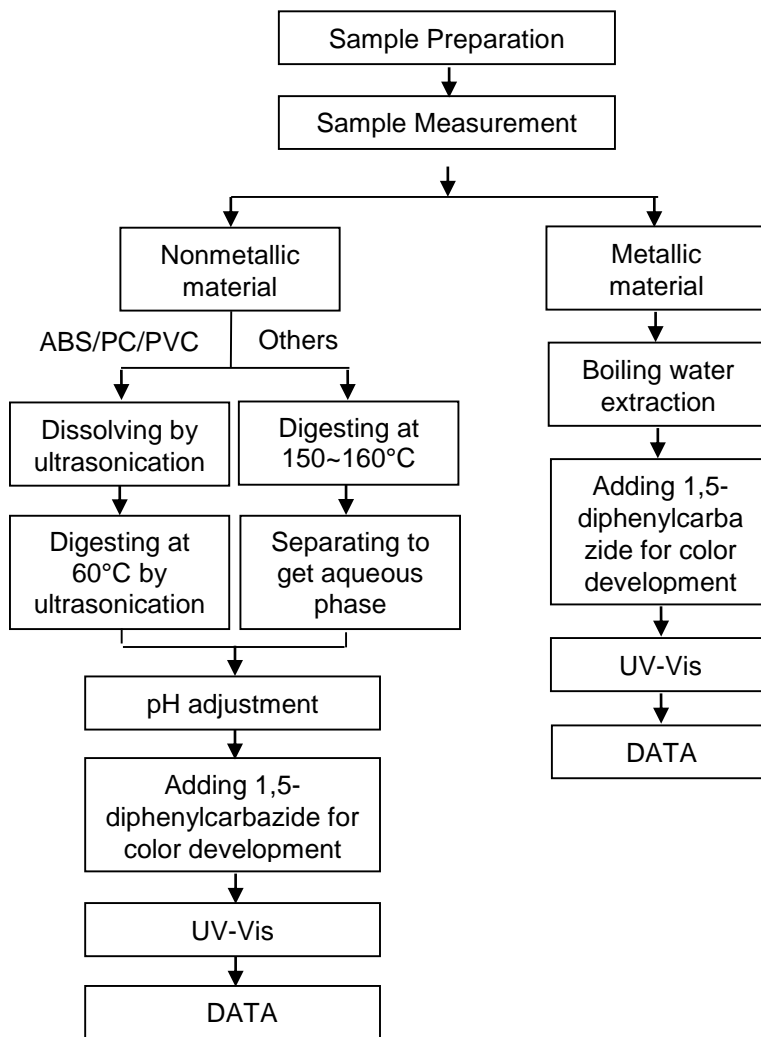

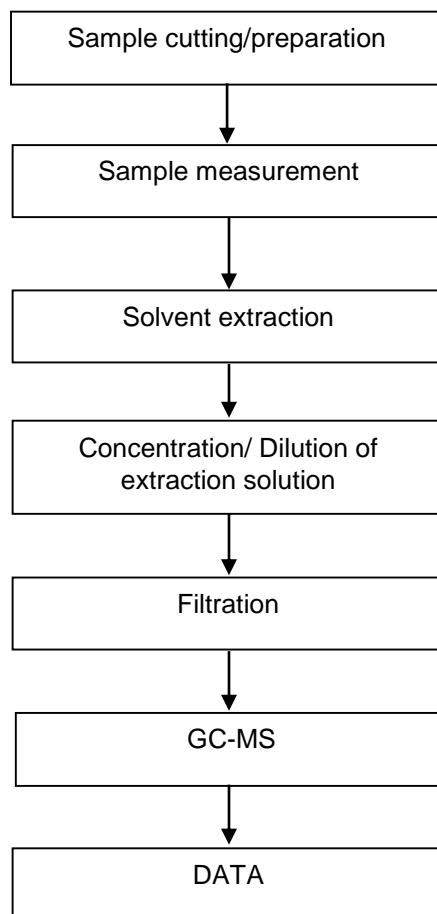

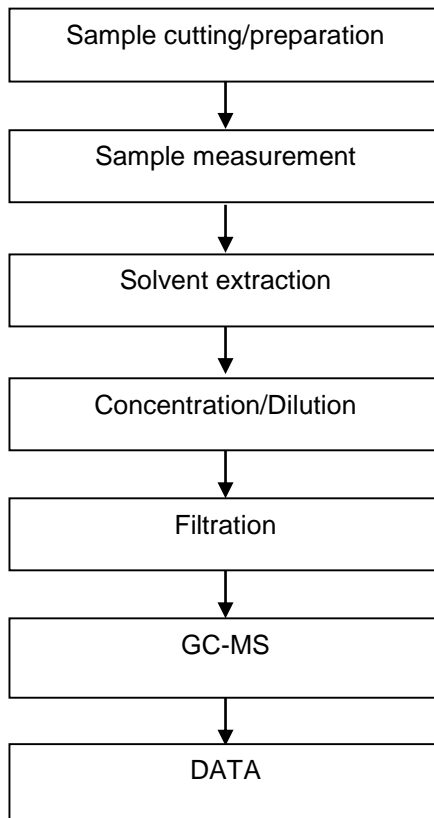

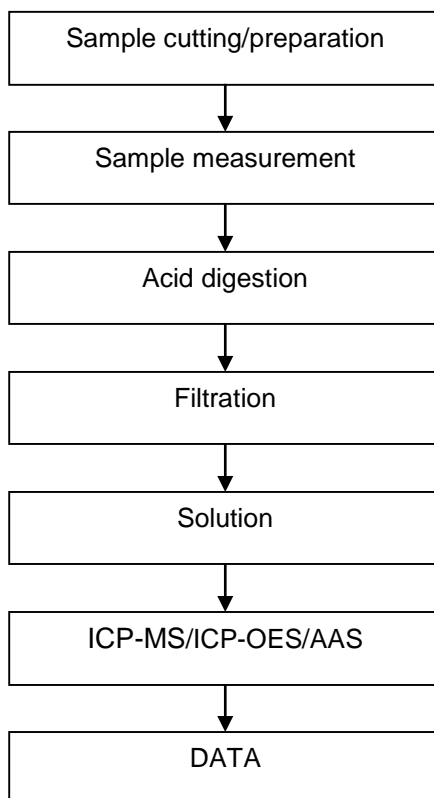

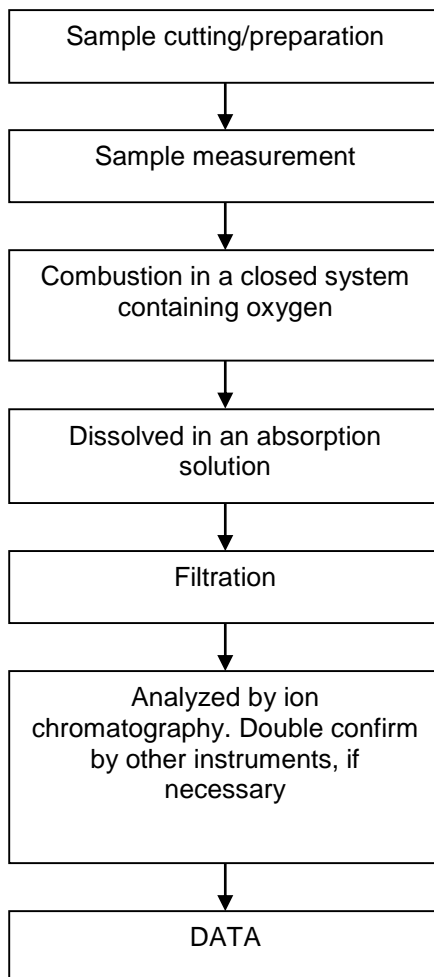
## Elements Testing Flow Chart

## Halogen Testing Flow Chart

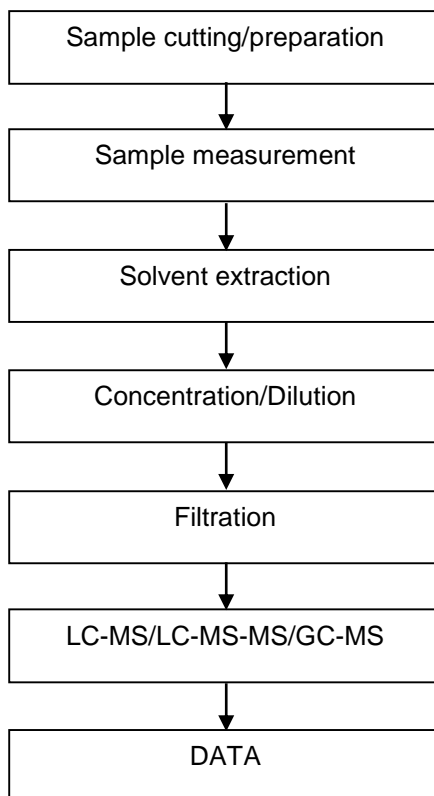

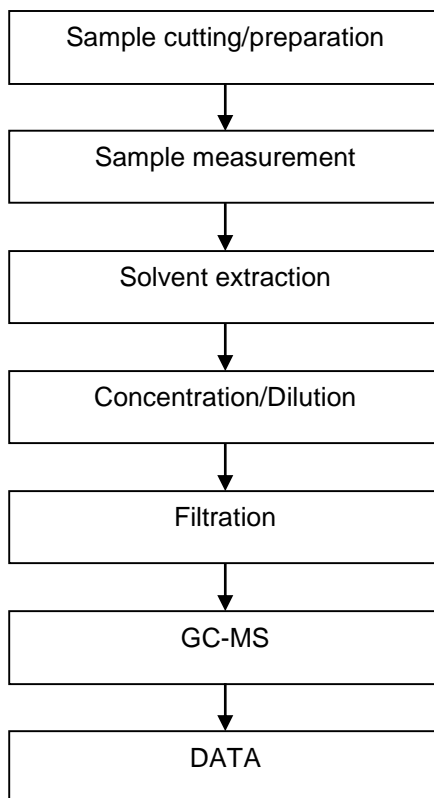

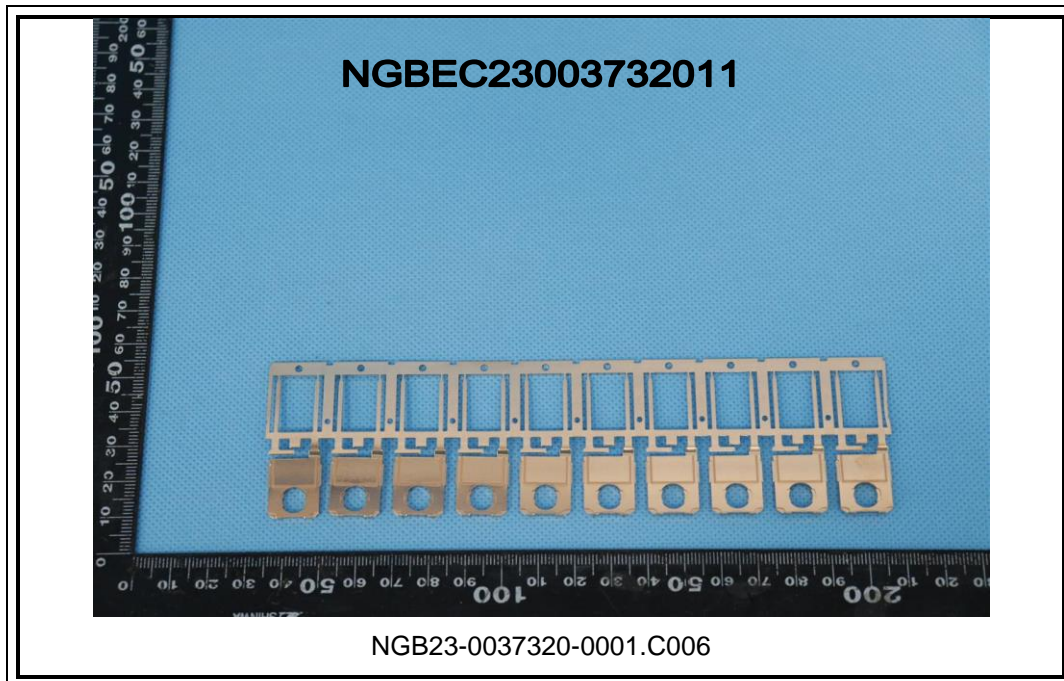
